

How to leave a bequest (or a gift in your Will) to FIRST LIGHT CARE FUND?

You may consider using one of the following suggested wordings in your Will to describe the type of gift you wish to leave to the FIRST LIGHT CARE FUND. FIRST LIGHT CARE FUND strongly recommends you to seek professional legal advice when preparing your Will.

It should be noted that according to the Wills act, all Wills and Codicils must be in writing, signed by the Testator, and attested by two witnesses in the presence of the Testator and of each other. In the event that the Testator does not understand English, the Will must be interpreted to the Testator by an interpreter, who must also sign the interpretation clause, and again attested by two witnesses in the presence of the Testator and of each other.

Once the Will has been signed, please send a copy of the signed Will, together with the contact details of your legal representative or the executor of your Will, to FIRST LIGHT CARE ASSOCIATION INC. of Shop 3, 99-101 Anzac Avenue, West Ryde NSW 2114, for its records.

1. To leave the residue of your Estate:
I give devise and bequeath to FIRST LIGHT CARE FUND (ABN 21 133 068 517) of Shop 3, 99-101 Anzac Avenue, West Ryde NSW 2114 to be used for its general purposes [the whole of] or [specific item(s) of] the residue of my Estate of whatsoever kind and wheresoever situate after the payment of all my just debts, funeral and testamentary expenses and all duties, taxes and charges payable on my Estate at my death. I declare that a written receipt of the proper officer of FIRST LIGHT CARE FUND for the time being shall be a complete and sufficient discharge to my executor who shall not be bound to see its application.
2. To leave a percentage of your Estate:
I give devise and bequeath to FIRST LIGHT CARE FUND (ABN 21 133 068 517) of Shop 3, 99-101 Anzac Avenue, West Ryde NSW 2114 to be used for its general purposes [percentage] of my Estate after the payment of all my just debts, funeral and testamentary expenses and all duties, taxes and charges payable on my Estate at my death. I declare that a written receipt from FIRST LIGHT CARE FUND shall be a complete and sufficient discharge to my executor who shall not be bound to see its application.
3. To leave a specific sum:
I give devise and bequeath to FIRST LIGHT CARE FUND (ABN 21 133 068 517) of Shop 3, 99-101 Anzac Avenue, West Ryde NSW 2114 to be used for its general purposes the sum of \$..... of my Estate after the payment of all my just debts, funeral and testamentary expenses and free of all duties and taxes payable at my death. I declare that a written receipt from FIRST LIGHT CARE FUND shall be a complete and sufficient discharge to my executor who shall not be bound to see its application.
